**PETITION FOR WITHDRAWAL OF APPEAL OF  
ACTIONS OF THE COMMISSION STAFF**

Southwestern Energy Production Company ("SEPCO") hereby petitions the Public Utility Commission ("Commission") pursuant to Section 1.82(a) of the Commission's regulations, 52 Pa. Code § 1.82(a), for leave to withdraw SEPCO's Petition for Appeal of Actions of the Commission Staff filed May 23, 2013 at this docket. In support of this petition, SEPCO respectfully represents the following.

1. On May 23, 2013, SEPCO petitioned for appeal from the determinations of the Commission Staff contained in a certain letter dated May 3, 2013 from Robert C. Gramola to John Nicholas, General Manager of SEPCO's Appalachian Division (the "Appeal Petition"). That petition requested the Commission to reverse the determinations contained in the May 3, 2013 letter and to direct a refund of an overpayment of a certain well impact fee.

2. No party has filed a response to SEPCO's petition and therefore it is an uncontested matter or proceeding before the Commission.

3. SEPCO desires to terminate this uncontested matter before final decision by the Commission. SEPCO therefore requests leave to withdraw its Appeal Petition and terminate this matter before the Commission.

WHEREFORE, for all the foregoing reasons, SEPCO respectfully requests the Commission to enter an order which:

1. Grants leave for SEPCO to withdraw its Appeal Petition and terminates this proceeding; and
2. Grants any additional relief which is just and reasonable under the circumstances.
