TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Pursuant to the Secretarial Letter issued by the Pennsylvania Public Utility Commission ("PUC" or "Commission") on February 25, 2022, in the above-captioned proceeding, Citizens' Electric Company of Lewisburg, PA ("Citizens'") and Wellsboro Electric Company ("Wellsboro") hereby submit the following Initial Comments regarding the Petition filed by ChargEVC-PA. As stated in the Secretarial Letter, these Initial Comments will address solely whether the Commission should initiate a proceeding and the parameters of the proceeding, if opened.

The ChargEVC-PA Petition was filed on February 4, 2022 at Docket No. P-2022-3030743, initiating a formal legal proceeding in which the Commission is requested to consider issuing a policy statement on one specific issue concerning electric vehicles ("EVs") based on perspectives, information and a series of questions posed by ChargEVC-PA. Citizens' and Wellsboro welcome the opportunity for a broad discussion on EVs with all interested stakeholders in a forum facilitated by the Commission. Citizens' and Wellsboro respectfully suggest that the process should be conducted in an informal manner, open to all potentially interested parties, and allow for information gathering on a broad scope of issues facing the Commission on the chosen topic. The Commission should structure the process to allow

stakeholders to participate remotely, like many Commission working groups have been conducting business over the last two years.
