RE: Development of an Efficient Loop Migration Process

The above captioned proceeding has been reassigned from the Fixed Utility Services (FUS) to the Office of Administrative Law Judge (OALJ). The Commission's Procedural Order implementing the *Triennial Review Order (TRO)* had directed the Bureau of Fixed Utility Services (FUS) to convene a collaborative technical conference. The scope of this proceeding includes consideration of the development of a batch hot cut process as well as the feasibility of a Commission specific-electronic loop provisioning requirement¹.

Comments received from parties indicate that a consensus agreement cannot be reached and there is the need for an on-the-record proceeding. Accordingly, the technical conference scheduled for March 11, 2004, was cancelled and parties are advised that the OALJ will provide further instruction.
