Dear Mr. Thompson,

I am writing to be considered for the available Board of Director position with the Sustainable Energy Fund. Attached is my resume and some additional information for your review.

I am currently a partner at Tucker Arensberg, P.C. and have been practicing business, litigation and intellectual property law in the Harrisburg area for 12 years. I am active in the community and have been and am currently involved with several other non-profit and business organizations throughout the state. I recently resigned from a long membership on a local 501(c)(3) Board and am looking to share my commitment to a new organization, like the SEF, that shares one of my life's passions, renewable energy, and energy education.

Prior to law school, and following my graduation from Lehigh University in 1997, I was the Energy Program Coordinator at the Clean Air Council, a regional non-profit organization actively involved in many air and energy related issues - not the least of which was advocating for the establishment of the sustainable energy funds which currently offer opportunities for Pennsylvania. My employment at the Clean Air Council was well timed, immediately following electricity deregulation in Pennsylvania, which spurred unprecedented opportunities for energy education and renewable energy. I joined the Clean Air Council initially to help implement a grant from the William Penn Foundation intended to educate consumers about the specifics of deregulation as well as their opportunity to purchase renewable energy.

The success of that program, combined with the apparent excitement about renewable energy among ordinary electricity consumers, led to other projects at the Council intended to increase local demand for renewable energy. Specifically, I participated with a group of entrepreneurs from Colorado in the first pilot project in the Philadelphia area (and possibly the entire state) to sell "blocks" of renewable energy, which were related to specific wind energy installations, directly to business consumers. Although grassroots in its infancy, it became what is now Community Energy and paved the way for many of the first large utility scale wind energy projects in Pennsylvania.



Several other programs at the Clean Air Council helped foster my knowledge and passion for renewable energy, including the Solar Schools Program and a "SimCity-like" energy education game for high school children, but explaining them here would create an overly long letter. Having been elected to the Clean Air Council Board of Directors following law school, I stay close to many issues that affect the renewable energy industry.

My legal practice has allowed me to continue development of skills that also benefit the renewable energy industry and non-profit community. My membership on several non-profit boards has enabled me to utilize my legal skills to benefit these organizations and help add value to my membership. At this stage in my career, I have developed experience which I am eager to share with the SEF.

Earlier this summer, in an effort to learn more about the SEF prior to submitting an application for a Board position, I met with prior Board member Kenneth Mickens, to discuss his role with the SEF Board and the various projects on the horizon for the organization. Having met with Mr. Mickens, and knowing of the long history of contributions made by the SEF since 2000, my interest in a Board position is confirmed.

Importantly, my energy advocacy related experience with the Clean Air Council, as well as the current Board position with that organization, helped kindle and maintain a life-long excitement for renewable energy which I am eager to share with the Sustainable Energy Fund.

Nominations Committee Recommendation


A motion (Eighmy, Snyder)
