ANSWER OF THE OFFICE OF SMALL BUSINESS ADVOCATE

Pursuant to 52 Pa. Code § 5.61(a), the Office of Small Business Advocate ("OSBA") submits this Answer to the Petition of UGI Utilities, Inc. – Electric Division ("UGI-E" or the "Company") for Approval of Phase IV of its Energy Efficiency and Conservation ("EE&C") Plan ("Petition") that was filed with the Pennsylvania Public Utility Commission ("Commission") on September 21, 2023.

Answer

After an initial review of the Petition, the OSBA has identified the following initial list of issues that it will evaluate in this proceeding:

- The OSBA will evaluate whether the Company has reasonably complied with the provisions of the settlement in the Phase III EE&C proceeding;
- The OSBA will evaluate whether the Company's actual reductions in customer loads is consistent with reported plan savings;
- Whether the Company's proposed Phase IV EE&C spending is reasonably balanced among and within the rate classes;
- Whether the Company has implemented reasonable controls to ensure that revenues and costs are correctly attributed to the EE&C rate class groups;
- Whether the Company's proposal to add two pathways to the non-residential EE&C programs is reasonable and will result greater participation by smaller non-residential customers; and
- Whether the Company's proposal to significantly shift programs from the Large C&I rate class group to the Small C&I group is reasonable and credible.

Conclusion

In view of the issues set forth above, the Office of Small Business Advocate respectfully requests that the Pennsylvania Public Utility Commission:

- A. Direct the Office of Administrative Law Judge to hold hearings on the *Petition* and prepare an initial decision; and
 - B. Grant such other relief as may be necessary or appropriate.

The Small Business Advocate is authorized and directed to represent the interest of small

business consumers of utility services in Pennsylvania under the provisions of the Small

Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 - 399.50 (the "Act"). The Act

further provides that the Small Business Advocate is to issue publicly a written statement stating

concisely the specific interest of small business consumers to be protected by his initiation of or

intervention in any proceeding involving those interests before the Public Utility Commission

("Commission") or any other agency or court. This public statement relates to the filing today

by the Small Business Advocate of an Answer and Notice of Intervention in the above-captioned

Commission proceeding.

On September 21, 2023, UGI Utilities, Inc. – Electric Division ("UGI-E" or the

"Company") filed a Petition for Approval of Phase IV of its Energy Efficiency and Conservation

("EE&C") Plan ("Petition") with the Commission.

The Small Business Advocate is intervening in this proceeding in order to protect the

interests of the Company's small business customers. A thorough inquiry by the Commission

into all of the elements of the Petition is necessary to ascertain whether the Company's proposed

EE&C plan is just and reasonable.

In view of the foregoing, the Small Business Advocate is requesting that the Petition be

subject to investigation and evidentiary hearings before the Commission. The Small Business

Advocate will ask the Commission to deny or modify any aspect of the Company's EE&C plan

proposal that is not proven by UGI-E to be just, reasonable, and non-discriminatory.
