PREHEARING CONFERENCE MEMORANDUM OF UGI UTILITIES, INC. – ELECTRIC DIVISION

TO DEPUTY CHIEF ADMINISTRATIVE LAW JUDGE MARK A. HOYER:

Pursuant to 52 Pa. Code § 5.222(d) and the Prehearing Conference Order dated October 18, 2023, UGI Utilities, Inc. – Electric Division ("UGI Electric" or "Company") hereby submits this Prehearing Conference Memorandum.

I. BACKGROUND

On September 21, 2023, UGI Electric filed the above-captioned Petition with the Pennsylvania Public Utility Commission ("Commission"), which included the Company's supporting written direct testimony and exhibits. This filing was made pursuant to the Commission's December 23, 2009 Secretarial Letter at Docket No. M-2009-2142851 ("December 23, 2009 Secretarial Letter"), which provided guidance on voluntary Energy Efficiency and Conservation Plans ("EE&C Plans") submitted by electric distribution companies that are not subject to Act 129 of 2008, P.L. 1592, 66 Pa.C.S §§ 2806.1 and 2806.2 ("Act 129").

In its Petition, UGI Electric requested Commission approval of the Company's voluntary Phase IV Energy Efficiency and Conservation Plan ("Phase IV EE&C Plan"). The voluntary Phase IV EE&C Plan includes a portfolio of energy efficiency and conservation practices and peak load reduction and energy education initiatives that are expected to reduce customers' energy consumption and reduce peak load on UGI Electric's system.

On October 11, 2023, the Office of Consumer Advocate ("OCA") filed an Answer to the

Petition.

Also on October 11, 2023, the Office of Small Business Advocate ("OSBA") filed a Notice

of Appearance, Public Statement, Answer, and Verification.

On October 18, 2023, the Prehearing Order was issued by Deputy Chief Administrative

Law Judge Mark A. Hoyer ("ALJ"), which, in part, scheduled a prehearing conference for October

25, 2023, at 10:00 AM and directed the parties to file prehearing memoranda on or before 3:00

PM on October 24, 2023.

UGI Electric observes that the Commission anticipates that voluntary EE&C Plan proceedings should conclude with a recommended decision within 12 months of the petition filing date. *See December 23, 2009 Secretarial Letter*, p. 1. However, the Company's current Phase III EE&C Plan is set to expire on May 31, 2024. Therefore, UGI Electric respectfully requests that the procedural schedule adopted in this proceeding be able to accommodate a final ruling by the Commission on the Phase IV EE&C Plan no later than the public meeting scheduled for May16, 2024.

V. <u>DISCOVERY</u>

To date, the Company has received and responded to interrogatories from the OSBA. UGI Electric is not aware of any discovery issues and does not propose any special orders regarding discovery. The Company is willing to work with the parties, through informal discovery, to expedite any additional discovery. Further, UGI Electric proposes that discovery conclude prior to the evidentiary hearing.

VI. PUBLIC INPUT HEARINGS

UGI Electric is not aware of any substantial consumer interest with respect to this proceeding. UGI Electric does not propose that any public input hearings be held absent substantial public interest in this proceeding and specific requests for such hearings.

VII. PROTECTION OF CONFIDENTIAL INFORMATION

UGI Electric will submit a Petition for Protective Order for consideration by the ALJ. The Company will seek the concurrence of the other parties as to the form of the Protective Order before submitting the Petition.

VIII. SETTLEMENT

To date, no settlement discussions have been held. However, UGI Electric is willing to work with the parties to resolve this proceeding through settlement. Further, UGI Electric would be willing to enter into a partial settlement, stipulate to certain facts, or both, in order to narrow the issues in this proceeding.
