**Approved applications for US Grid Energy; MSI Utilities Inc.; Groundswell Inc.; Infinity Power Partners LLC; DWP Energy Holdings LLC; Columbia Gas of Pennsylvania Inc.; South Canaan Telephone Co., South Canaan Long Distance Co. and Laurel Highland Total Communications Inc.; Stahlstown Telco Inc.; Stahlstown Ldco Inc.; and Specialized Moving Services Inc. (Allegheny County).**

**Adopted the proposed opinions and orders** tentatively approving an application for **Palmco Energy PA Inc.**; granting the petition and amending the 2006 order as requested by the petitioners regarding the proceedings of **Pittsburg and Shawmut Railroad Inc.**; approving the proposed settlement, which includes a \$5,000 civil penalty in the case of Bureau of Transportation and Safety (BTS) and Clarion County Taxi (**Clarion County**); denying the petition for reconsideration and adopting the administrative law judge's (ALJ's) initial decision in the case of Deidra Alston vs. **National Fuel Gas Distribution Corp.**; granting the petition for reconsideration, in part, and modifying the ALJ's initial decision in the case of Douglas Park vs. **PPL Electric Utilities Corp.**; denying the petition for reconsideration, in the case of Douglas Champlin vs. **PPL Electric Utilities Corp.**; denying the exceptions and adopting the special agent's initial decision in the case of Ramona Foster Lang vs. **PECO Energy Co.**; denying the petition for reconsideration and

adopting the ALJ's initial decision in the case of Shymar McBride vs. **UGI Utilities Inc. – Gas Division**; denying the complainant's exceptions and adopting the special agent's initial decision in the case of Robert S. Brossman vs. **PECO Energy Co.**; denying the exceptions, adopting the initial decision and dismissing the complaint with prejudice in the case of Thomas and Margery McCarey vs. **PECO Energy Co.**; and approving the settlement between the Commission's Bureau of Investigation and Enforcement (I&E) vs. **UGI Penn Natural Gas Co.**

**Adopted the proposed orders** approving the 2013 price stability index/service price index filing of **CenturyLink**; granting the petition of **Nexus Communications Inc.** for designation as an **eligible telecommunications carrier (ETC)** in the Commonwealth of Pennsylvania; and granting the petition of **Life Wireless** for designation as an ETC for the limited purpose of offering Lifeline service in the Commonwealth of Pennsylvania; and granting the petition of **Stahlstown Telco Inc.** as an ETC.

**Made public United Water Pennsylvania Inc.'s management efficiency investigation (MEI) report and implementation plan and the annual report of the management audits and MEIs performed for the Fiscal Year 2012-13.**

**Approved an increase in rates** for Harrisburg City Cab Inc. (**Dauphin County**); Easton Taxi (**Northampton County**); and **Millcreek Paramedic Service Inc.**

**Denied an increase in rates** for Yellow Cab Co. of Pittsburgh (**Allegheny County**); Metro Taxi (**Crawford County**); and Erie Yellow Cab (**Erie County**).

**Instituted an investigation** into the proposed rate increase request of **Duquesne Light Co.**

**Registered securities certificates for Columbia Water Co.**

**Approved the 911 system renewal plan for Montour County.**

**Adopted the proposed policy statement regarding utility service outage response, recovery and public notification.**

**Adopted the ALJ's recommended decision accepting the annual 1307(e) generation supply charge reconciliation statement for the over/under collections for the period of May 1, 2012, to April 30, 2013, for PPL Electric Utilities Corp.**

**Adopted the motion of Vice Chairman Coleman regarding the affiliated interest agreement of PPL Electric Utilities Corp.**

**Adopted the joint motion of Chairman Powelson and Commissioner Witmer in the case of William Towne vs. Great American Power LLC.**
