Formal Complaint (FC) filed on 7/8/20, regarding quality of service. Complainant alleges that: (1) the water provided by Pittsburgh Water and Sewer Authority (PWSA) to the service address was unsafe due to low chlorine levels; (2) PWSA has wrongfully refused to replace the service line serving the service address under the baseless contention that it is a private line; and, as such, (3) the Complainant and his affected neighbors are forced to pay for their own water line repairs on a service line that experiences frequent breaks. As relief, the Complainant requested that PWSA build a new water service line to his service address, which supplies water containing appropriate chlorine levels. On 7/19/23, the Commission issued the Initial Decision (ID) of ALJ Dunderdale, which sustained the FC, in part, and denied it, in part, finding that PWSA failed to provide reliable, safe, and quality water service to the Complainant's service address by failing to provide reasonable and adequate maintenance and repair services between 5/2018 and 11/2020, and by unreasonably replacing and relocating the Complainant's curb stop and service line. On 8/8/23, PWSA and the Complainant filed Exceptions to the ALJ's ID. The Complainant filed Reply Exceptions on 8/18/23.
