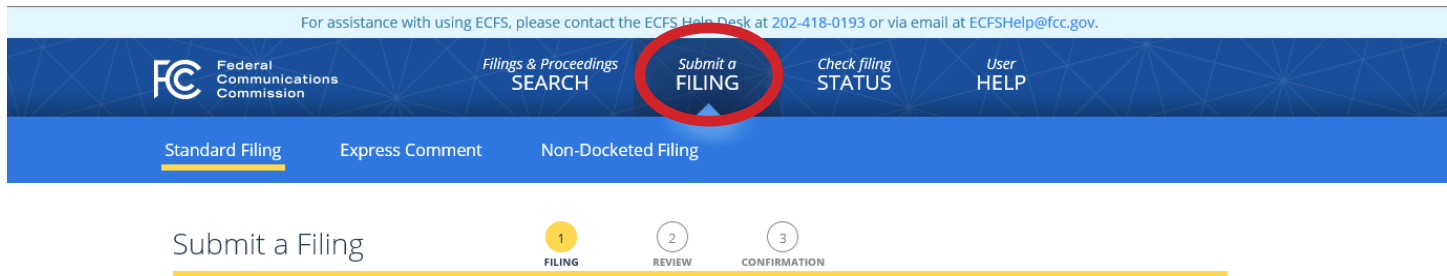




# Instructions for the Filing of Comments to Support Pennsylvania’s Rural Broadband Petition at the Federal Communications Commission Electronically or By Mail

## ELECTRONICALLY

Visit the FCC’s Electronic Comment Filing System, at: <https://www.fcc.gov/ecfs/>  
Click on the “Submit a Filing” tab, at the top of the page:



### ON THE “SUBMIT A FILING” PAGE, ENTER THE FOLLOWING REQUIRED INFORMATION USING THE DIALOG BOXES:

**Note:** *These fields must be completed to submit a filing – other fields can be left blank.*

- **PROCEEDING(S)** – 10-90, 14-58, 14-259  
*Note: Add the first docket number (10-90), press the ENTER key, add the second docket number (14-58), press the ENTER key, and add the third docket number (14-259), and press the ENTER key to include all three dockets. If entered correctly, they will appear as follows:*

After you have entered the information in those fields, use the “Upload Documents” box to attach your message or letter. Up to 5 files/comments can be attached to a submission.
