Approved applications for Advance Care Ambulance (**Bucks County**); Healthcare Transportation Service LLC (**Philadelphia, Bucks, Chester, Delaware and Montgomery counties**); Veron A. Leslie Jr. (**Lancaster County**); Bruce J. Byram (**Lancaster County**); Barbara Hughes (**Centre County**); Jack Hess (**Lancaster County**); **Stream Energy Pennsylvania LLC**; **Pennsylvania American Water Co.**; and **Leatherstocking Gas Company LLC**.

Approved application as amended for Pennsylvania Department of Transportation (PennDOT) (**Westmoreland County**).

Dismissed applications for Paradise Transit Inc. (**Delaware, Montgomery, Chester, Bucks, Berks and Lancaster counties**); **Kays Gravel Co.**; and **TH Port-A-Johns**.

Denied application for Amedeo's Limousine Service Inc. (**Delaware County**).

Approved increases in rates for John C. Mummau (**Cumberland and Franklin counties**); Ronald F. Wallace (**Northumberland County**); Bucks County Transport Inc. (**Bucks County**); Grab-A-Cab (**Berks County**); Carbon Taxi (**Carbon County**); and Clarion County Taxi Inc. (**Clarion County**).

Approved the generation supply adjustment for **PECO Energy Co. – Electric** and the generation supply service rates for **Citizens' Electric Co. of Lewisburg** and **Wellsboro Electric Co.**

Adopted the proposed opinions and orders approving the proposed settlement, which

includes a civil penalty of \$100, in the case of **BTS vs. Metro Taxi (Erie County)**; denying the company's exceptions to the initial decision, approving the application and adopting the initial decision as the action of the Commission with regard to the application of Samir Ouagerrouch (**Delaware County**); approving the proposed settlement in the informal investigation of **Windstream Pennsylvania LLC's** "no proration" billing practice; denying the applicant's exceptions to the initial decision, approving the application, in part, and denying, in part, and adopting the initial decision in part as the action of the Commission regarding the application of **Two Men and a Truck (Beaver, Bulter, Westmoreland, Fayette and Washington counties)**; granting the joint petition for approval of an interconnection agreement between T-Mobile Northeast LLC and **Verizon North Inc.**; granting the joint petition for approval of an interconnection agreement between Verizon Wireless and **Verizon Pennsylvania Inc.**; granting the joint petition for approval of an interconnection agreement between Verizon Wireless and **Verizon North Inc.**; granting the joint petition for approval of a local wireline network interconnection and traffic exchange between Service Electric Telephone and **Verizon North Inc.**; granting the joint petition for approval of an interconnection agreement between NTELOS and **Verizon Pennsylvania Inc.**; granting the joint petition for approval of an interconnection agreement between NTELOS and **Verizon North Inc.**; granting the joint petition for approval of an interconnection agreement between T-Mobile and **Frontier Communications Commonwealth Telephone Co.**; granting the joint petition for approval of an interconnection agreement between T-Mobile and **Frontier Communications of Canton LLC**; granting the joint petition for approval of an interconnection agreement between T-Mobile and **Frontier Communications of Breezewood**

Adopted the proposed reconsideration order on the joint petition for **Metropolitan-Edison's**, Pennsylvania Electric Company's, Pennsylvania Power Company's and West Penn Power Company's default service plans

Adopted the proposed orders directing that the complaint be sustained and that the certificate be canceled regarding the complaint filed against Kids In Motion Inc. (**Chester County**); approving the application for approval of exemption from the Commission's clearance requirements as amended for Kiski Junction Railroad Inc. (**Armstrong County**); approving the letter of notification of **PPL Electric Utilities Corp.** with respect to the siting and construction of the Peckville-Paupack 230-kV line and the Paupack-Blooming Grove 230-kV line in Paupack Township, **Wayne County**; approving the letter of notification of **Metropolitan Edison Co.** for approval to install the North Lebanon-North Temple 230-kV HV transmission line loop to the Northkill Substation project in Jefferson Township, Berks County; approving Supplement No. 50 to Tariff Electric – Pa. PUC No. 4 of **PECO Energy Co. - Electric** proposing a tariff change and an interim adjustment to the transmission service charge rates to become effective Oct. 1, 2012; denying the petition of

Dominion Retail Inc., Interstate Gas Supply and Shipley Choice LLC for a declaratory order asking the Commission to rule that its transition orders establishing an ongoing duty on natural gas distribution companies to provide natural gas suppliers with customer lists at no charge; granting the petition for temporary waiver of 52 Pa. Code §56.42 requesting that the Commission permit **Metropolitan Edison Co., Pennsylvania Electric Co., Pennsylvania Power Co. and West Penn Power Co.** to employ a 20-day due date instead of a 21-day due date for deposit bills, through Dec. 31, 2012; and issuing for comment the **interim guidelines for natural gas eligible customer lists** similar to those established for the electric industry in 2011.

Adopted the proposed final order approving the universal service and energy conservation plan for 2011-13 for **West Penn Power Co.**

Adopted the proposed secretarial letter and released the end state proposal regarding the **investigation of Pennsylvania's retail electricity market**; and **certifying 34 rural telecommunications carriers' eligibility for federal high-cost support**, Verizon Contel and Verizon Quaker State study area's eligibility for local switching support, and that **Verizon PA and Verizon North's** residential rates in rural areas are reasonably comparable for purposes of section 254(b)(3) of the Telecommunications Act of 1996, respectively.

Adopted the proposed reconsideration order for Phase 2 of the Act 129 Energy Efficiency Program.

Approved the proposed rate increase for Nantmeal Warwick Sewer Co. Inc.

Approved the 911 system renewal plans for Cumberland and Pike counties.

Adopted the ALJ's recommended decisions approving the settlement without modification regarding the **rate increase request of Peoples Natural Gas Co. LLC**; and approving the joint petition for complete statement regarding the **definitive** purchase gas cost filing proposing changes in rates resulting from changes in the

purchased gas costs for **PECO Energy Co. – Gas**; and approving the settlements for **the annual purchased gas cost filings** of **UGI Central Penn Gas Inc.** and **UGI Utilities Inc. – Gas Division.**

Approved the motions of Commissioner Witmer regarding the binding poll addressing the petition of **PECO Energy Co. – Electric** requesting approval of its default service plan for the period from June 1, 2013, through May 31, 2015.
