In an effort to provide more detailed information about the actions taken during its Public Meetings and increase transparency, the Pennsylvania Public Utility Commission (PUC) is providing an enhanced Public Meeting Agenda.

The agenda contains a summary of each of the issues considered by the Commission during the Public Meeting. It also includes a tally of how the Commissioners voted on each of the agenda items as well as links to motions and statements issued by Commissioners during the meeting. The agenda also is searchable by key words (Ctrl F then input the company name, action, word for which you are looking).

The following document provides step-by-step instructions on how to use the enhanced search mechanisms on the Commission's website to learn more about each of the decisions and cases leading up to the decision.
