- Application filed on 12/28/04, seeking to abolish eleven crossings. On 12/28/09, ALJ Nene issued a Recommended Decision, which, inter alia, assigned responsibility for the removal of a structure at a crossing in Snyder Township. Exceptions and Replies were filed. Per Order entered on 4/20/10, we determined that the pertinent structure was a tunnel and that the cost of its removal should be divided equally between Snyder Township and PennDOT. The April 2010 Order was subsequently amended to grant PennDOT an extension of time to investigate whether a roadway realignment project would be beneficial. On 12/19/13, PennDOT filed a Petition to Modify and Amend Order with respect to the crossing. PennDOT avers that the Township does not object to its Petition. No Answer to PennDOT's Petition has been filed.
