However, various discrete issues regarding the implementation of the DSIC surcharge mechanism that were not fully addressed in our 8/2/12 Order have arisen. with the immediate commencement of service by Knox at the same rates and with the same terms and conditions of service as provided by Orwell. A Joint Petition for Approval of Application and

Adoption of Settlement Agreement was filed 7/20/15.

COMMISSION REVIEW:

That the Commission adopt ALJ Buckley's Recommended Decision approving the settlement without modification.

- Application filed on 11/5/12. Protests were filed 5/24/13. An ALJ hearing was held 2/11/14. The protests were withdrawn upon the filing of a restrictive amendment. By Order dated 4/3/14, the ALJ reassigned the application to the Bureau of Technical Utility Services (TUS). By letter dated 5/20/14, TUS informed 610 Hauling that the application was incomplete and requested additional information. By Order entered 8/21/14, the application was denied for failure to provide the requested information. On 9/5/14, 610 Hauling filed a Petition for Reconsideration, claiming it had provided the information. By Order entered 11/13/14, the Commission granted the petition, vacated the 8/21/14 Order, and referred the application back to TUS for further action. By Secretarial Letter dated 5/8/15, the application was denied on its merits for failure to establish need and propensity to operate illegally. On 6/2/15, 610 Hauling filed a second Petition for Reconsideration.

RECOMMENDATION:

That the Commission adopt the proposed Opinion and Order, which grants the second Petition, rescinds the Secretarial Letter, and grants the application as amended.
