The investigation related to allegations that a door-to-door sales agent employed by a third party marketing vendor of WGL Energy stole a wallet from a potential residential customer. I&E was prepared to allege in a formal complaint that WGL Energy or its agent engaged in fraudulent, deceptive or otherwise unlawful acts in violation of the Commission's regulations pertaining to marketing of EGS services. On 7/10/15, the Parties submitted a Settlement Agreement and Statements in Support of the Settlement to resolve this matter. By an Order entered 11/5/15, the Commission issued the settlement for comments. No comments were filed.

That the Commission adopt the proposed Opinion and Order that approves the settlement as clarified.

By Initial Decision issued on 6/29/15, ALJ Johnson sustained the Complaint, finding that Duquesne provided unreasonable service related to the installation of the utility pole and damage to the Complainant's sidewalk. The ALJ also found that Duquesne violated Commission regulations pertaining to the investigation of a customer's complaint, assessed a civil penalty of \$5,000, and directed Duquesne to repair the sidewalk. On 7/20/15, Duquesne filed Exceptions. On 8/3/15, the Complainant filed Replies to the Exceptions.
