METROPOLITAN EDISON COMPANY, PENNSYLVANIA ELECTRIC COMPANY, PENNSYLVANIA POWER COMPANY, AND WEST PENN POWER COMPANY

- Management Efficiency Investigation evaluating the implementation of selected recommendations from the 2014 Focused Management and Operations Audit. The scope of the investigation was an examination of the progress in implementing 27 of the 28 original recommendations from the Focused Management and Operations Audit release in February 2015. Staff found that FirstEnergy-Pennsylvania (FE-PA) Companies have effectively or substantially implemented 13 of the prior recommendations reviewed and taken some action on the remaining recommendations. Staff has made 14 follow-up recommendations for improvement. FE-PA submitted an Implementation Plan dated 9/17/18, indicating acceptance of 12 of the follow-up recommendations and partial acceptance of two. Reportedly, the FE-PA Companies have fully implemented one of the recommendations as of October 2018 and plan to implement the remaining recommendations by December 2019.

### NAME AND SUBJECT

### **UGI UTILITIES INC - ELECTRIC DIVISION**

- On 1/26/18, UGI filed its Tariff Electric PA P.U.C. Nos. 6 and 2S, proposing an increase in revenues of approximately \$9.254 million, based on data for the fully projected future test year ending 9/30/19. The Bureau of Investigation and Enforcement (I&E) filed a notice of appearance and Complaints against the proposed rate increase were filed by the OCA, the OSBA, Matthew Josefwicz, and Barbara McDade. Public input hearings were held on 4/18/18. Evidentiary hearings were held on 6/11/18 and 6/12/18. By Recommended Decision issued on 8/24/18, ALJs Haas and Calvelli recommended, in part, that UGI be permitted to increase annual revenues up to \$2.789 million. On 9/13/18, UGI, I&E, the OCA and the OSBA filed Exceptions. On 9/24/18, UGI, I&E, the OCA and the OSBA filed Replies to Exceptions.

That the Commission conduct a BINDING POLL of the issues to address the Exceptions and Replies to Exceptions filed by the Parties in response to the ALJs' Recommended Decision.
