HELP FOR AFFORDABLE BROADBAND

Emergency Broadband Benefit (EBB) Federal Programitrans Affordable Connectivity Program

What is the Affordable Connectivity Program?

One of the programs to come out of the Infrastructure Investments and Jobs Act is the Affordable Connectivity Program (ACP), which will expand and make permanent the temporary Emergency Broadband Benefit (EBB) program created in response to COVID-19 as the funding source to provide discounts on broadband for income-eligible households. This program is being funded for \$14.2 billion, which is part of the \$65 billion aimed at broadband issues.

How Much is the Average ACP Support?

The program will provide eligible households with discounts of up to \$30 a month for broadband service. Eligible households can also get a one-time discount of up to \$100 on equipment to use the internet. Equipment includes a computer or tablet if they contribute \$10-\$50 toward the price for the equipment. The benefit is limited to one service discount per month and one device discount per household. This ACP is in addition to, not in place of, the current Lifeline Program that provides \$9.25 a month to support affordable broadband service.

Who is Eligible for the ACP?

The program is income based. For example, it is open to <u>Lifeline</u> subscribers and households that currently participate in Lifeline, including consumers whose income is at or below 200% of the federal poverty guidelines or who receive WIC, Medicaid, SNAP, SSI, Federal Housing or Veterans benefits. Consumers who receive free or reduced-price school lunch, or have received a federal Pell grant, are also eligible.

Households that qualified for the Emergency Broadband Benefit due to a substantial loss of income due to job loss or furlough since Feb. 29, 2020, or by meeting the eligibility criteria for a participating provider's COVID-19 program will need to requalify for the ACP. Failure to re-qualify will result in the loss of the benefit as of March 1, 2022. More information is available on the FCC website.

How Can Consumers Get the ACP?

The ACP is scheduled to open on Dec. 31, 2021. At this time, consumers can still apply for the EBB Program and will continue to receive their current monthly benefit during a 60-day transition period.
