<sup>\*\*\*</sup> In order to include information regarding the number of customers who have switched during the reporting month together with the percentage of load (volume of gas in Mcf) delivered by alternative suppliers, it is necessary to compile actual usage information based on monthly customer meter readings and billing processes. Complete usage data is not immediately available with the settlement process ranging from 30 to 60 days.
