PETITION OF PHILADELPHIA GAS WORKS FOR LEAVE TO WITHDRAW ITS MOTION FOR PARTIAL SUMMARY JUDGMENT

Pursuant to 52 Pa. Code § 5.94(a), Philadelphia Gas Works ("PGW") submits this Petition for Leave to Withdraw the Joint Motion for Partial Summary Judgment in the above-captioned consolidated matter. In support of this Petition, PGW states as follows:

- 1. On March 9, 2010, PGW and Clean Air Council (CAC) filed a Joint Motion for Partial Summary Judgment (Motion) to Approve Settlement for Expedited Implementation of Residential DSM Programs (Settlement). That same day, they also filed a Joint Petition for Interlocutory Review of a Material Question (Joint Petition).
- 2. The Motion, Settlement and Joint Petition were contested by the Office of Trial Staff (OTS), the Office of Consumer Advocate (OCA), the Office of Small Business Advocate (OSBA). Two consumer organizations, Tenant Union Representative Network and Action Alliance of Senior Citizens of Greater Philadelphia (TURN) filed a Letter in Opposition to the Joint Petition.

- 3. On April 15, 2010, the Commission (a) determined that the Joint Petition was improper; and (b) returned the Motion and Settlement to the Office of Administrative Law Judge for further proceedings.
- 4. In light of the Commission's Order of April 15, 2010 and the upcoming hearings (which are scheduled to begin on May 10, 2010), PGW respectfully requests that the Commission grant this petition to withdraw the Motion. Upon doing so, the issues may be decided in the hearing (or settlement) of these proceedings.
 - 5. CAC joins this request to withdraw the Motion.

WHEREFORE, Philadelphia Gas Works respectfully requests that the Commission grant this petition to withdraw its Motion. Upon doing so, the issues may be decided in the hearing (or settlement) of these proceedings.
