Enclosed are an original and three (3) copies of the executed **CONFIDENTIAL** Agreement between FirstEnergy Service Company (on behalf of Metropolitan Edison Company, Pennsylvania Electric Company and Pennsylvania Power Company) ("the Companies") and ADM Associates, Inc. ("ADM") to provide evaluation, measurement and verification ("EM&V") services for approved Energy Efficiency and Conservation programs being implemented by the Companies' in accordance with Act 129 of 2008.

The Agreement consists of four **CONFIDENTIAL** documents:

- a Purchase Order, setting forth pricing and additional terms of the Agreement;
- the FirstEnergy Services Company Master Services Agreement;

In awarding this contract, the Companies followed the approved Competitive Bidding Process for Conservation Service Providers, which was submitted to the Commission and approved by Secretarial Letter dated March 18, 2009. 


