Dear Secretary Chiavetta:

On December 22, 2009, FirstEnergy Service Company, on behalf of Metropolitan Edison Company, Pennsylvania Electric Company and Pennsylvania Power Company ("the Companies"), filed with the Commission a Conservation Service Provider ("CSP") agreement with Honeywell Utility Solutions ("Honeywell") for the provision of program management services for approved residential programs under the Companies' Act 129 Energy Efficiency and Conservation Plans. The Commission issued a Secretarial Letter dated January 7, 2010, advising the Companies that the proposed CSP agreement was approved. Subsequently, the Companies and Honeywell have been implementing various residential Act 129 Energy Efficiency and Conservation programs pursuant to this approved agreement.

On July 2, 2010, the Companies and Honeywell executed a Change Order to the initial Purchase Order to include the provision of marketing services for approved programs for residential customers to help achieve the Companies' goals set forth in Act 129. The Companies are filing the executed CONFIDENTIAL change order at this time **for informational purposes only** and to complete the Commission's file regarding this agreement.




