



3. PCOC anticipates that the issues to be considered are a review of the Amended EE&C Plan in respect to its meeting the energy conservation and demand response goals of Act 129. Specifically, PCOC has filed Comments and reserves the right to present testimony in this matter addressing the application of Act 129 resources toward achieving Act 129 low income energy efficiency objectives. PCOC has specifically addressed PECO's Plan:
  - a. To provide resources dedicated to multi-family properties providing affordable housing to low-income families; and
