On April 20, 2011, FirstEnergy Service Company ("FirstEnergy"), on behalf of West Penn Power Company ("West Penn") (together with FirstEnergy, "the Companies") filed an executed **CONFIDENTIAL** Agreement between the Companies and PowerDirect Energy ("PDE") ("Agreement"). The Companies originally filed this Agreement in Docket Numbers M-2009-2092222, M-2009-2112952 and M-2009-2112956, which were the docket numbers for Metropolitan Edison Company, Pennsylvania Electric Company and Pennsylvania Power Company's Joint Petition for Consolidation of Proceedings and Approval of Energy Efficiency and Conservation ("EE&C") Plans.

Please be advised that the Companies intended to file this Agreement in **West Penn's** Petition for Approval of its Energy Efficiency and Conservation Plan, **Docket No. M-2009-2093218**. However, due to clerical error, the original correspondence enclosing the Agreement contained the wrong docket numbers, namely, the docket numbers for Met-Ed, Penelec and Penn Power's Joint Petition for Approval of their EE&C Plans, Docket Numbers M-2009-2092222, M-2009-2112952 and M-2009-2112956.

Consequently, the Companies respectfully request that the original Agreement (along with the original cover letter) be filed under the correct docket number, **M-2009-2093218**. The only change to the original filing is on the first page of the cover letter enclosing the Agreement in the "Re:" line, where the incorrect docket numbers are listed. The substance of the cover letter and enclosed documents remain the same.



