Please accept this letter and supplement to Telephone Pa. P.U.C. No. 6 (Resold Interexchange Services) as notification that Business Telecom, Inc. is changing its name under which it provides intrastate interexchange long distance services in Pennsylvania to Business Telecom, Inc. d/b/a EarthLink Business III. Effective with this filing, the Company will no longer market its services as Business Telecom, Inc. d/b/a BTI Telecommunications Services. The Company's presubscribed customers have been notified of this change.
