Enclosed are an original and three (3) copies of the executed **CONFIDENTIAL** Agreement between FirstEnergy Service Company ("FirstEnergy") (on behalf of West Penn Power Company) ("Company") and Honeywell International, Inc. ("Honeywell") to provide services for the Company's approved Act 129 Energy Efficiency and Conservation programs for residential customers including the Energy Star Products Program, the Home Performance (Walk through Audit and Whole Building Comprehensive) Program, the HVAC Program and the CFL Program.

The Agreement consists of four **CONFIDENTIAL** documents:

- A Purchase Order, setting forth pricing and additional terms of the Agreement;
- The FirstEnergy General Terms and Conditions;
- The Honeywell Formal Proposal; and
- The Honeywell Pricing Proposal.

The FirstEnergy General Terms and Conditions contained in the Agreement are substantially similar to the FirstEnergy General Terms and Conditions that were approved by Secretarial Letter in the Petition of West Penn Power Company d/b/a Allegheny Power for Approval of its Energy Efficiency and Conservation Plan, Approval of Recovery of Costs through a Reconcilable Adjustment Clause and Approval of Matters Relating to the Energy



The Company recognizes that Commission staff has 45 days from filing to review and approve the enclosed Agreement in accordance with the Commission's Act 129 Implementation Order. However, to the extent possible, the Company respectfully requests an expedited review and approval of this contract so that the program can be implemented immediately.

Due to the financially sensitive and proprietary nature of the information contained in this Agreement, the Company respectfully requests that the Commission accord the Agreement the highest possible confidential treatment under the Commission's regulations.



