**PA PUBLIC UTILITY COMMISSION
SECRETARY'S BUREAU**

BY THE COMMISSION:

On June 8, 2011, the Bureau of Transportation and Safety instituted a complaint against Rosemont Taxicab Co., Inc., alleging that respondent permitted its driver to operate its vehicle while he did not possess a valid driver's license, a violation of 52 Pa. Code §29.502 and §29.12 in that it did not comply with the Motor Vehicle Code at 75 Pa. C.S. §1543(a), failed to maintain safe, adequate, efficient, and reasonable service and facilities for the proper safety of its patrons and public, a violation of 66 Pa. C.S. §1501; and failed to maintain logs for at least two (2) years, a violation of 52 Pa. Code §29.313(c).

Respondent was duly notified that, if an answer was not filed within twenty (20) days from the date on which the complaint was served, then the Bureau of Transportation and Safety would request the Commission to enter an order imposing a fine. The complaint and notice were served on respondent on June 10, 2011; and, to date, more than thirty (days) later, no response has been received from respondent. Therefore, the allegations in the complaint are admitted and the complaint shall be sustained.

THEREFORE, IT IS ORDERED:


1. That the allegations in the complaint are deemed admitted.

2. That the complaint is sustained.

3. That the respondent, within twenty (20) days from the date of service of this order, pay a fine of one thousand, three hundred dollars (\$1,300.00), by certified check or money order payable to the **Commonwealth of Pennsylvania** and forwarded to Rosemary Chiavetta, Secretary, Pennsylvania Public Utility Commission, at P.O. Box 3265, Harrisburg, PA 17105-3265, as provided in the Public Utility Code, 66 Pa. C.S. §3301 and 3315.

4. That the respondent cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§101, et seq., and the Regulations of this Commission, 52 Pa. Code §§1.1, et seq.
