Pursuant to the September 14, 2011 letter received from Assistant Counsel Patricia T. Wiedt, enclosed please find the amended CSP contract filing between FirstEnergy Service Company ("FirstEnergy") (on behalf of West Penn Power Company) ("Company") and SAIC Energy, Environment & Infrastructure, LLC ("SAIC") to provide services for the Company's approved Act 129 Energy Efficiency and Conservation programs for commercial and industrial customers.

In that correspondence, Ms. Wiedt indicated that the Company needed to add four items to its CSP contract in order for this Agreement to be approved. The omission of those terms was an oversight. As a supplement, we have enclosed a signed copy of the Supplemental Terms and Conditions for Contracts with Conservation Service Providers, which is the same as the supplement filed in the Company's CSP Contract Filing with Power Direct on April 20, 2011 (corrected on April 28, 2011) and approved by the Commission on May 4, 2011.

The Company recognizes that Commission staff has 45 days from filing to review and approve the enclosed Agreement in accordance with the Commission's Act 129 Implementation Order. However, to the extent possible, the Company respectfully requests an expedited review and approval of this contract so that the program can be implemented immediately.


