**PREHEARING CONFERENCE MEMORANDUM OF  
WASHINGTON GAS ENERGY SERVICES, INC.**

Pursuant to 52 Pa. Code § 5.22, Washington Gas Energy Services, Inc. (WGES), hereby submits its Pre-Hearing Conference Memorandum in this matter.

**INTRODUCTION**

On November 17, 2011, Metropolitan Edison Company (Met-Ed), Pennsylvania Electric Company (Penelec), Pennsylvania Power Company (Penn Power), and West Penn Power Company (West Penn) (collectively, the “First Energy Companies”) filed a Joint Petition for Approval of their Default Service Implementation Plans at Docket Nos. P-2011-2273650, P-2011-2273668, P-2011-2273669 and P-2011-2273670. The Joint Petition was filed pursuant to Section 2807(e) of the Public Utility Code.

On December 19, 2011, WGES filed its Petition to Intervene in this matter. WGES is represented in this matter by the following counsel:

**(a) Whether the four dockets should be consolidated into one case**

WGES supports the consolidation of the four dockets into one case.

**(b) The possibility for settlement of the proceeding.**

WGES is amenable to discussing settlement of any and all of the issues raised by the parties to this proceeding

**(c) Whether the matter should be decided upon legal briefs, or whether a hearing is necessary.**

WGES is open to the possibility of deciding the case on briefs, but believes it would be prudent to reserve such a determination until parties have had the opportunity to review the testimony that is submitted in the proceeding.

**(d) Procedural Schedule**

WGES is amenable to the procedural schedule proposed by the Joint Applicants.

**(e) Advance submission of written testimony and information requests**

WGES favors advance submission of written testimony, and takes no position on the proposal for advanced submission of written information requests.

**(f) Other matters**

WGES is amenable to the exchange of exhibits prior to hearing, the obtaining of stipulations of fact, and other similar steps to facilitate the conduct of the hearing. WGES is agreeable to reasonable deadlines for discovery, as well as reasonable modifications to the Commission's regulations regarding discovery. WGES consents to accept electronic service of all documents on the deadlines for their delivery, followed by hard copy delivery by first class mail to its counsel. 
**WITNESSES**
