
Attached hereto as Exhibit A please find a regulatory status chart for Access One, Inc.

TUS-2 Provide a detailed update on the status of the Pennsylvania state tax liens entered against the Company in the Dauphin County Court of Common Pleas. If said liens have been satisfied, provide proof of such. Case Numbers 2007-CV-07930-NT (\$545.38, Plaintiff: Pennsylvania Department of Revenue, entered 08/09/2007) and 2010-CV-05933-NT (\$6450.00, Plaintiff: Pennsylvania Department of Revenue, entered 05/04/2010).¹¹

Case Number 2010-CV-05933-NT – This matter relates to a 2008 RCT-111 filed under the amnesty program. Initially, the payment submitted failed to post to the Access One, Inc. account. In December, 2010, Access One, Inc.'s transactional tax provider, faxed copies of the cancelled check to the Pennsylvania Department of Revenue ("DOR") confirming payment of this obligation. At this time, the DOR indicated this matter would be cleared. We have reviewed the DOR's lien list updated as of April 1, 2012 and find no evidence of an outstanding lien. In this instance, we believe the court system may not have current information for this item.

Case Number 2007-CV-07930-NT – This matter relates to a sales tax lien. We attach as Exhibit B a copy of the check stub and tracking information to confirm payment of this outstanding lien.

I, Patrick D. Crocker, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing held in this matter. I understand that the statements herein are made subject to the penalties of 18 Pa. C.S. § 4904 (relating to unsworn falsification to authorities).
