Dear Secretary Chiavetta:

The Law Bureau Prosecutory Staff (LBPS) seeks leave to withdraw the motion for judgment on the pleadings in the above referenced case.

LBPS had filed a complaint against Global NAPs South, Inc., *et al.* (hereinafter collectively "GNAPs") alleging that it failed to comply with or obey the Commission's orders, failed to provide safe and reliable service that conforms to the regulations and orders of the Commission, and refused to pay tariffed access charges. When GNAPs failed to answer the complaint in a timely manner, LPBS file a motion for judgment on the pleadings and asked that relief be granted to revoke GNAP's certificate of public convenience and to order GNAPs to immediately cease operations in Pennsylvania.

GNAPs is no longer certified to conduct business in Pennsylvania and is in bankruptcy proceedings; therefore, the matter is now moot. As a result, LBPS seeks leave to withdraw its motion for judgment on the pleadings.


