
1. A certain portion of the proposed Northeast – Pocono Reliability Project may traverse a portion of the land owned by Bradley D. Hummel in Salem Township, Wayne County, Pennsylvania.

2. A portion of the proposed Northeast-Pocono Reliability project that may traverse the portion of land owned by Bradley D. Hummel will have severe impact on existing and future land use reducing potential areas for residential or commercial development.

3. PPL Electric Utilities failed to work with the property owner, Bradley D. Hummel, to locate a right-of-way across his land that would minimize the impact on existing and future land uses.
4. Bradley D. Hummel is willing to locate a right of way across his land that would minimize the impact of existing and future land uses.
5. Bradley D. Hummel offered this alternative right of way proposal to PPL.
6. Bradley D. Hummel seeks to have a resolution to this matter that would benefit both parties, not solely PPL.

WHEREFORE, Bradley D. Hummel respectfully requests the Pennsylvania Public Utilities Commission to grant intervention in the above matter.




