The insured is in no way at fault, as there was an accounting difference between brokers. We having taken over from the previous brokers on February 1st 1977.

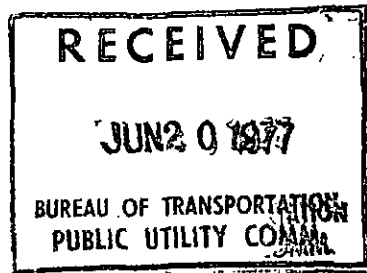
