This is to advise you that on or about December 14, 1988, a certain motor vehicle, herein identified as a Ford truck, bearing New Jersey License No. XE59KV, Identification No. DYA92XXEVA10636, further identified as Company No. 374, leased to you by Able Rental, Inc., Delran, New Jersey, was checked by Gary E. Ellex, a duly authorized enforcement officer of this Commission, at or near Route No. 61, Frackville, Schuylkill County, Pennsylvania, and the following deficiencies were observed:

It was found that the said motor vehicle combination failed to display your certificate of public convenience number on the sides of the power unit, as required by 52 Pa. Code §31.33(b).

52 Pa. Code §31.33(b) states:

"Each motor carrier shall cause to be painted on each side of every motor vehicle operated by him, in letters not less than two inches in height, and not less than 1/2 inch in width, the name and address of such motor carrier and the number of the certificate of public convenience or permit as 'PA P.U.C. NO. A. If the follows: vehicle is owned by someone other than the motor carrier operating it, there shall be shown on each side of the vehicle, in letters not less than two inches in height and not less than 1/2 inch (in width, the wording: 'OPERATED BY (name and address? of authorized motor carrier), PA P.U.C.
NO. A. ______'. If a removable device is used to identify the operating carrier as lessee, such device shall be of durable material and securely affixed, to the vehicle operated, throughout the duration of the lease."

In light of the above, you are hereby directed to comply with the aforesaid regulation within fifteen (15) days of receipt of this letter and submit proof of compliance to this office forthwith. Failure to comply may subject you to the penalties as may be imposed by this Commission for violation of its regulations.
