
Dear Secretary Chiavetta:

This letter is to advise the Pennsylvania Public Utility Commission (“Commission”) and the active parties to the above-captioned proceeding that PPL Electric Utilities Corporation (“PPL Electric”) is delaying the effective date of the proposed Storm Damage Expense Rider (“SDER”). Pursuant to the Commission’s Opinion and Order issued November 15, 2013, the proposed SDER was suspended by operation of law until February 28, 2014. Given the impending expiration of the suspension period and the extensive comments and reply comments filed in this matter, PPL Electric believes it is appropriate to voluntarily extend the suspension period for the SDER until April 30, 2014, with the SDER then going into effect on May 1, 2014.

Under separate cover, PPL Electric will file Supplement No. 148 to its Tariff – Electric Pa. P.U.C. No. 201 (“Tariff”) to implement the above-described extension and suspend the proposed SDER until April 30, 2014, with the SDER then going into effect on May 1, 2014.
