

Sunbury Pa. 17801 am filing a protest against the following application for authority, Lyft Inc. 548 Market st. San Francisco CA 94104 Docket# 2014-2415047. Filing under Code 52 *Chapter 3* 3.381. We would accept no restrictions to the application. We currently hold authority under the following tariffs A-00119340 City of Sunbury Northumberland County, Borough of Northumberland Pa. Northumberland County, Borough of Shamokin Dam Pa. Borough of Hummelswarf Pa, and Borough Selinsgrove Pa. Snyder County, Upper Augusta Township Northumberland County, A-00119340F2 Borough of Lewisburg Pa. Union County, Borough of Milton Pa. Northumberland County, and 5 air miles from the border of these boroughs. A-2010-2152783 so as to permit the transportation of persons in paratransit service for the Pa. Department of Welfare of Northumberland and Union Counties including careerlink clients in Union County, and patients of Evangelical Hospital, between points, and within a 10 mile air radius of the boroughs of Lewisburg, West Milton, Milton, Watsonstown, Mifflinburg, Montandon, and Turbotville. To allow the Lyft Inc. to service any of the following areas would severely impact our operations. This would reduce our income and cause layoffs of our staff. We currently provide excellent service to all areas listed on our tariffs. Allowing Lyft Inc. to service our area would be detrimental to everyone involved, causing two weaker businesses and put the risk of loss of service to everyone in our areas. I am again asking that we accept no restrictions to the application. I would also like to mention that Lyft Inc. could not possibly cover all the area applied for in their application, the application is extremely broad. I would like to thank you for your time in reviewing this protest which I have filed.


