Re: Request by Constellation NewEnergy-Gas Division to Amend Natural Gas Supplier License No. A-125095

Dear Secretary McNulty:

Constellation NewEnergy-Gas Division, LLC (CNE-Gas) is a licensed Natural Gas Supplier in the Commonwealth of Pennsylvania.<sup>1</sup> CNE-Gas is authorized by the Pennsylvania Public Utility Commission (Commission) to provide natural gas services to the public within the service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, UGI Utilities, Inc., and the Peoples Natural Gas In the Commonwealth of Pennsylvania CNE-Gas presently provides gas Company. services only to industrial customers located in the service territories of these utilities.

CNE-Gas respectfully requests the Commission amend CNE-Gas' existing license to include T.W. Phillips Gas and Oil Co., and Equitable Gas Company. If approved, in addition to its present business activities CNE-Gas will solicit natural gas-related business only from industrial customers in the service territories of T.W. Phillips and Equitable Gas. CNE-Gas does not presently offer such service to customers behind either of these utilities.

Based upon discussion with Commission Staff, CNE-Gas understands that the following information is required to support our request:

1. Evidence that CNE-Gas has met the creditworthiness standards of T.W. Phillips and Equitable Gas. (A) Enclosed is a letter from Jay W. Dawson, T.W. Phillips, stating that T.W. Phillips is satisfied with the qualifications of CNE-Gas. Per

instructions from Mr. Dawson, CNE-Gas will execute a form of security with T.W. Phillips once the volume of gas to be supplied is determinable, which will occur after CNE-Gas' amended license has been approved by the Commission. (B) Enclosed is a copy of an electronic transmission (email) from Domenic R. Scapes, Equitable Resources, Inc., stating that CNE-Gas is in compliance with the creditworthiness standards of Equitable Gas. CNE-Gas is advised by Commission Staff that evidence in the form of an email is acceptable to the Commission.

2. Proof of publication in the newspapers distributed in the geographic area served by T.W. Phillips and Equitable Gas of notice of intent to provide natural gas and related services in the Dominion Peoples' service territory. Enclosed are copies of our initial newspaper notices in January 2001 for: the *Williamsport Sun-Gazette*; the *Scranton Times*; the *Post-Gazette*; the *Philadelphia Inquirer*; the *Patriot News*; and, the *Erie Times-News*. Please note that the notice states our intent to "sell natural gas and related services throughout all of Pennsylvania." It is the understanding of CNE-Gas that if the initial newspaper notice indicated intent to provide service statewide then a notice at this time to support the request herein is not required.

CNE-Gas respectfully requests that the Commission approve the request herein to amend the existing license of CNE-Gas to include T.W. Phillips Gas and Oil Co., and Equitable Gas Company as utility service territories in which CNE-Gas is authorized to provide natural gas supply services.


