

VERIFIED STATEMENT OF J. TYSON COVEY

B.A.R. 301 and 1012.1, Michelle Painter, Esq., a member of the bar of the Commonwealth of Pennsylvania (Attorney ID No. 91760), is moving for my admission *pro hac vice* in the above-captioned proceeding. In support of said sponsor's motion, I, the candidate, J. Tyson Covey, submit this verified statement, pursuant to Rule 1012.1:

1. I am admitted to practice in and am a member in good standing of the bar of Illinois, having been admitted in 1991. I have never been suspended, disbarred, or otherwise disciplined nor am I currently the subject of any disciplinary proceeding.
