NOTE AA - When distance from original point of origin to final destination is:

- (a) 10 miles or less - flat charge shall be one hour at the applicable rates
- (b) 11 to 20 miles - flat charge shall be one and one-half hours at the applicable rates.
- (c) 21 to 40 miles - flat charge shall be two hours at the applicable rates.

Totaling the new income should the proposed increase be approved as follows results in \$23,962 of increased revenues. For the current period of November 2013 to October 2014, revenues generated were \$2,480,000. Applying 1% of \$2,480,000 results in a total of \$24,800 compared to the projected revenues of \$23,962.
