This letter is filed pursuant to the Order Granting Second Motion for Continuance dated December 29, 2014. Specifically, Respond Power LLC (“Respond Power”) advises Your Honors and the parties that as of this date, it intends to conduct cross-examination of all of the consumer witnesses for whom written testimony was submitted by the Office of Attorney General/Office of Consumer Advocate (“Joint Complainants”) and the Bureau of Investigation and Enforcement (“I&E”).

In an effort to assist the Joint Complainants and I&E with the scheduling of consumer witnesses to testify during the hearings scheduled for March 9-13, 2015, Respond Power will endeavor to identify by February 9, 2015 at least sixty witnesses for whom cross-examination will be necessary. Additionally, Respond Power expects to have more complete information to provide by February 17, 2015 when cross-examination hearing exhibits are due to be circulated.


