On December 30, 2014, Respond Power LLC (“Respond Power”) filed a Motion for Scheduling of Settlement Conference and Assignment of Settlement Judge (“Motion”) in the above-captioned matter. By letter dated January 8, 2015, Respond Power asked that you hold the Motion in abeyance. As a result, the parties were not required to file responses to the Motion by the date previously directed by you of January 9, 2015.


At this time, Respond Power wishes to renew the Motion and asks that you establish a new response date. In renewing this Motion, Respond Power is not suggesting that the Joint Complainants or the Bureau of Investigation and Enforcement (“I&E”) have not engaged in good faith settlement discussions.

Rather, Respond Power simply believes that the parties’ settlement positions are too divergent for meaningful progress to be made. It is our view that the participation in these settlement discussions by an administrative law judge would facilitate our efforts to reach a comprehensive settlement with the Joint Complainants and I&E.


