Dear Ms. McCann:

By Order entered November 24, 2004, at Docket Nos. A-311294, A-311294 F0002, and A-311294 F0003, the Commission approved the application of DigitalSpeed Communications, Inc. (DIGITALSPEED) to provide service as an Interexchange (IXC) Toll Reseller, Competitive Local Exchange Carrier (CLEC), and Competitive Access Provider (CAP) to the public in the Commonwealth of Pennsylvania. The Company has filed Telephone PA PUC Tariff No. 1, Telephone PA PUC Tariff No. 2, Telephone PA PUC Tariff No. 3, and Telephone PA PUC Tariff No. 4, all with effective dates of January 25, 2005.

This letter is to notify you that the IXC Tariff No. 1, CLEC Tariff No. 2, CAP Tariff No. 3, and Switched Access Tariff No. 4 have been permitted to become effective. This permission does not constitute a determination that the tariffs are just, lawful, or reasonable, but only that suspension or further investigation does not appear to be warranted at this time.

DIGITALSPEED is also directed to add its Pennsylvania tariffs to its website within thirty (30) days from the date of this letter. Upon placing the tariffs on its website, DIGITALSPEED shall contact Cyndi Page (717-787-5722; cypage@state.pa.us) of the Commission's Communications Office to inform her of the tariffs' website address. In order to maintain a true and accurate representation of its tariffs on file with the Commission, DIGITALSPEED should continually update its tariffs whenever supplemental revisions are approved by the Commission.

If DIGITALSPEED does not maintain a website, the Pennsylvania Public Utility Commission will host its tariffs on the Commission's website. Contact Cyndi Page for instructions on how to have your tariffs and/or tariff supplement(s) added to the Commission's website.

The determination to permit the tariffs to become effective is without prejudice to any complaint timely filed against the proposed tariffs.
