On May 30, 2006, the Commission received the Application of Salsgiver Telecom, Inc., for approval to provide telecommunications services as a Facilities-Based Reseller of Competitive Local Exchange, Reseller of Toll Services and Interexchange Toll Facilities-Based Carrier Services. The application for Facilities-Based Reseller of Competitive Local Exchange was area specific to the service territories of Verizon North, Alltel Pennsylvania, Inc. and North Pittsburgh Telephone Company, and was docketed at A-311373F0002.


On June 16, 2006, a Secretarial Letter was issued to Salsgiver Telecom, Inc., granting provisional authority. This provisional authority included the approval to provide Facilities-Based Reseller of Competitive Local Exchange Carrier Services to the public in the service territories of Verizon North, Alltel Pennsylvania and North Pittsburgh Telephone Company.

Please be advised that the provisional authority granted with respect to Facilities-Based Reseller of Competitive Local Exchange Carrier Services in the service territory of Alltel Pennsylvania and North Pittsburgh Telephone Company was issued in error. This type of service in the service territory of Alltel Pennsylvania, Inc., and North Pittsburgh Telephone Company falls under 66 Purdon's §1102, and therefore, notice must be published in the Pennsylvania Bulletin and in a newspaper of general circulation where the Applicant intends to provide service.

Accordingly, this letter is to rescind that portion of the June 16, 2006 Secretarial letter granting provisional authority to Salsgiver Telecom, Inc seeking approval to provide Facilities Based Reseller of Competitive Local Exchange Carrier services in the service territories of Alltel PA and North Pittsburgh Telephone Company. Salsgiver Telecom is directed to publish the enclosed notice in a newspaper of general circulation in the area involved and file proof of publication with the Commission on or before July 24, 2006. Please note the new docket number assigned to the Alltel Service Territory is A-311373F0002AMA and the North Pittsburgh Telephone Company is A-311373F0002AMB.

Please be advised that Salsgiver Telecom does have provisional authority for the following: Facilities-Based Reseller of Competitive Local Exchange Carrier Services in the service territory of Verizon North docketed at A-311373F0002; Reseller of Toll Services docketed at A-311373F0003, and Interexchange Toll Facilities-Based Carrier Services docketed at A-311373F0004.
