
Glose Moving & Storage, Inc. is seeking increases in hourly rates for the transportation of household goods in use for forty (40) miles and less.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Saturdays and Weekdays (Any Hour): 4 hours at rates named in Columns 1 and 3 and 1 and 4.

NOTE 2 - Supervisor hourly rate will be charged at \$3.00 above driver hourly rate.

NOTE 3 - Article(s) weighing in excess of 250 pounds will be assessed a charge of \$50.00 per article in addition to hourly rates above.

NOTE AA - A flat charge based on one (1) hour at the applicable transportation rates shown in Columns 2, 3, and 4 is applicable when distance from original point of origin to final destination is 10 miles or less.

NOTE BB - A flat charge based on one and one-half (1.5) hours at the applicable transportation rates shown in Columns 2, 3, and 4 is applicable when distance from original point of origin to final destination is more than 10 miles but not exceeding 20 miles.

NOTE CC - A flat charge based on two (2) hours at the applicable transportation rates shown in Columns 2, 3, and 4 will be applicable when distance from original point of origin to final destination is more than 20 miles (to 40 miles inclusive).
