

PUBLIC STATEMENT OF THE OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Acting Consumer Advocate determined to intervene and participate in the Petition of PECO Energy Company for Approval of its Act 129 Phase III Energy Efficiency and Conservation Plan before the Commission.

On November 30, 2015, PECO Energy Company (PECO or the Company) filed its Petition for Approval of its Act 129 Phase III Energy Efficiency and Conservation Plan (Phase III Plan) with the Commission, pursuant to Section 2806.1 of the Public Utility Code and pursuant to the Implementation Order entered by the Commission at Docket No. M-2014-2424864 on June 19, 2015. The total five-year cost of the Company's EE&C Phase III Plan is projected to be \$427.4 million. The Company plans to reduce annual energy consumption by 2,100,875 MWh and reduce demand by 171 MW by May 31, 2021. With respect to residential customers, PECO has proposed to continue or implement five programs: (1) Lighting, Appliance and HVAC Solutions; (2) Residential New Construction Solutions; (3) Whole Home Solutions; (4) Appliance Recycling Solutions; and (5) Behavioral Solutions. PECO has also proposed residential demand response programs.

The Acting Consumer Advocate determined to intervene in this proceeding to: protect the interests of PECO's customers; to ensure that the proposed Plan and programs are in accordance with Act 129 and all other applicable statutes, regulations, and Commission Orders; and to ensure that any increase in rates resulting from the adoption of the proposed programs and any related expenses are just and reasonable.


