



On November 30, 2015, PPL Electric Utilities Corporation ("PPL" or "Company"), filed with the Pennsylvania Public Utility Commission ("PUC" or "Commission") a Petition for approval of the Company's Phase III Energy Efficiency and Conservation ("EE&C") Plan ("Phase III Plan" or "Plan"), pursuant to the requirements of Act 129 of 2008, 66 Pa. C.S. 2806.1 ("Act 129") and the PUC's Implementation Order entered on June 11, 2015, at Docket No. M-2014-2424864.

4. Nest Labs is a manufacturer of smart thermostats. Nest Labs has sold thousands of smart thermostats throughout the Commonwealth of Pennsylvania and within the PPL service territory. 
