

Before the Pennsylvania Public Utility Commission (the “Commission”), pursuant to 52 Pa. Code §§ 5.222, Intervenor, NextEra Energy Power Marketing, LLC, (“NextEra”), by its undersigned counsel, hereby respectfully submits this Prehearing Memorandum.

I. INTRODUCTION

1. Pursuant to Section 2807(e) of the Public Utility Code, on May 2, 2016, Duquesne Light Company filed a Petition for Approval of its Default Service Program and Procurement Plan (“Plan”) for the period June 1, 2017 to May 31, 2021. NextEra is filing its Petition to Intervene in this proceeding simultaneously herewith.

II. REVIEW OF THE PLAN

2. At this time, NextEra is reviewing the Plan and still formulating its position on the issues, including any position on settlement. NextEra is also considering the extent to which it will participate in the proceedings, and, thus, does not have a specific position on scheduling or discovery. NextEra reserves the right to present in this proceeding direct, rebuttal, and surrebuttal fact and expert testimony, to the extent it deems necessary. If it does submit testimony, it is

anticipated NextEra will offer one witness, and NextEra will notify the Administrative Law Judge and all parties of the witness's identity as appropriate.
