Dear Judge Long:

To date, Pennsylvania Power Company ("Penn Power" or the "Company") has been served with a number of formal complaints in the above-captioned matter and anticipates that additional formal complaints will be filed. On June 9, 2016, the Commission entered an Order initiating an investigation of the Company's rate increase request at the above-referenced docket number. The Company anticipates that all complaints filed with respect to its proposed rate increase will be consolidated in that proceeding. Accordingly, with respect to the complaints for which an answer would be due after the Commission's June 9, 2016 Order, and any complaints hereafter filed, the Company will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.
