Dear Secretary Chiavetta,

Thank you very much for returning my telephone call yesterday and for the time you spent explaining the manner in which to request a change in time for the Public Input Hearing on the above referenced action. You indicated you would pass this request on to Judge Vero, the Administrative Law Judge.

Although you indicated that the 1 pm time on July 8 was reserved for the hearing in Hanover Township, it was changed to 6 pm with the 1 pm time period allotted to the East Stroudsburg community. I understood from our conversation at the time that this date and/or time could change, which was unfortunate for our community.

As you know, the Bridle Path community is comprised mainly of senior citizens, 200 of whom have signed the petition to deny the water rate increase. Residents range in age from 55 to 95, and it is difficult for many of them to make the 6 pm meeting on Friday. Also, there is a planned event in the community to which many residents have previously committed their time.

We are requesting that Judge Vero, through your office, reconsider and switch the time to 1 pm on July 8 for the Hanover Township hearing, reserving the 6 pm time for the people in East Stroudsburg. Alternatively, if Judge Vero allowed a different day and time for our hearing, many of our residents would be more able to attending during morning or afternoon hours.
