Dear Secretary Chiavetta:

On July 28, 2016, Fair View Energy, Inc. (Fair View) filed with the Pennsylvania Public Utility Commission (Commission) a Motion to Strike *Ex Parte* Communication of Non-Party in the above-referenced matter. Please be advised that the Bureau of Investigation and Enforcement (I&E) does not oppose Fair View's Motion.

However, notwithstanding I&E's non-opposition to striking the communication, I&E strongly disagrees with the remaining substance of Fair View's Motion, wherein Fair View espouses its position regarding whether the principals of Fair View knew that a license, issued by the Commission, to operate as an electric generation supplier (EGS) broker was required prior to engaging in EGS brokering activities in the Commonwealth. To the contrary, I&E intends to demonstrate at evidentiary hearing that Fair View's principals were keenly aware of this Commission's regulatory requirement.
