Dear Secretary Chiavetta:

On August 4, 2016, the Commission entered a Tentative Order which, among other things, addressed the budget for the Low-Income Usage Reduction Program (“LIURP”) of Philadelphia Gas Works (“PGW”). Specifically, the Commission directed a budget lower than the current budget under which the LIURP program has been operating in PGW Fiscal Year 2016. To be clear, due to the lead time in LIURP contracting, no changes in the level of services related to a changed budget would be required until the beginning of November 2016. In the event that a Final Order establishing the LIURP budget for Fiscal Year 2017 (and thereafter) is not issued in this proceeding by approximately September 30, 2016, PGW expects that it may need to file for additional input from the Commission regarding the ongoing spending while the proceeding remains open.
