Statement Nos. 3-R and 10-R were originally served on August 17, 2016 and addressed, among other things, the Direct Testimony of Paul Alvarez on behalf of the Environmental Defense Fund ("EDF") and the Direct Testimony of Michael Murray on behalf of EDF and Citizens for Pennsylvania's Future ("PennFuture"). On August 25, 2016, the Direct Testimony of Messrs. Murray and Alvarez was stricken by the Interim Order of Administrative Law Judge Mary D. Long granting the Company's Motion to Strike.
